**APPLICATION FOR DERELICT MOTOR VEHICLE CERTIFICATE AND REQUEST TO CANCEL TITLE**

This form must be used by the owner of a derelict motor vehicle, as defined in section 319.30, Florida Statutes, who is arranging for the delivery and/or sale of the derelict motor vehicle to a licensed salvage motor vehicle dealer or a registered secondary metals recycler when the title, salvage title or certificate of destruction is not available. The licensed salvage motor vehicle dealer or registered secondary metal recyclers may use this form to apply for a duplicate Derelict Motor Vehicle Certificate. The derelict motor vehicle must be worth less than \$1,000, is in such condition that its highest or primary value is for sale, transport, or delivery to a licensed salvage motor vehicle dealer or registered secondary metals recycler for dismantling its component parts or conversion to scrap metal and must be at least ten model years old.
